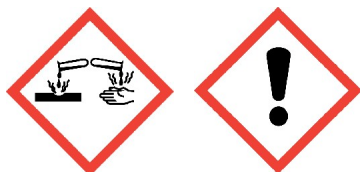

ACCIDENTAL RELEASE MEASURES
